Toward establishment of a new Consumer Association on food safety: key actives and results

- Consumers awareness raising on consumer protection law and on consumer association: conducted through different meetings and workshops organized by CIRD
- A core team or Task Force was established in mid 2022 to prepare for establishment of CA
- 3 Meetings of Task Force were conducted to draft the statute of the future CA and to prepare all required steps to follow for the establishment of CA
- A Statute of Consumer Association on Food Safety (CAFS) was drafted and available for further consultation with consummers who are interested to be founders of the association (to get the draft statute please click this link:
